OBJECTIVE

The Fund seeks to generate superior risk-adjusted returns for investors by aiming to mitigate traditionally high volatility and the various custody and counterparty risks associated with investing directly in Crypto Assets. The Sub Manager believes that the impact of DeFi, NFTs, and on-chain smart contracts is being underestimated in the Crypto Asset space. This results in certain industries facing rapid structural decline whilst new, previously unimagined industries are being created that have potential for rapid scaling and profitability.

INVESTMENT APPROACH

The Fund takes the view that long-term macro market level themes dominate micro level themes. Accordingly, the Fund follows a multi-disciplinary approach in order to identify both dominant macro themes in the Crypto Asset space, as well as the most promising Crypto Assets within those themes. It does so by utilising deep industry knowledge and thematic analysis, as well as fundamental, bottom-up research on individual assets. Capital will be allocated prudently, and positions managed actively using both targeted as well as dynamic asset allocation.

The Fund's strategy mitigates risk and reduces volatility by investing in a basket of diversified Crypto Assets across the various layers of the Crypto Currency, DeFi, Smart Contract and NFT stack. The portfolio is constructed predominantly with a fundamental long-term view but will also take advantage of short-term opportunities. It will employ trading strategies across various durations and risk profiles while keeping a close eye on valuation, liquidity, volatility and each individual Crypto Asset's margin of safety.






RISK/RETURN COMPARISON
